NEW Move & Delivery Policy. Modifications have been made to the Move & Delivery Policy, which is available for download on the Forms page on redhauscondos.com.

Moves (in or out) and large deliveries must be Booked at least 72 hours prior to your move date.

To create a booking, the Move & Delivery Scheduling Form with accompanying \$150 security fee must be submitted to the Site Office.

Moving and delivery trucks may not exceed 26 feet to comply with fire lane safety and the Calgary Parking Authority. Trucks exceeding this length will be turned away and fined.

NEW Owner & Tenant Form Bundle. For those moving into the Red Haus complex, all required forms have been combined into one easy bungle of download on the Forms page of the resident website. Bylaws require that owners maintain up-to-date records on behalf of their tenants.


Recent Property Maintenance. The following site activities have been completed recently. Your patience and cooperation is ever appreciated.

Q&A: visitor parking pass process

How do I request a parking pass?

In person at the Site Office (located in the Club Haus)
By phone at 403 452 8800
By email at office@redhauscondos.com

When can I request a parking pass?

8:30am – 4pm Monday to Friday, excluding holidays

What information is needed?

vehicle make, model, plate, building & unit number, dates (7 day max.)

What if I missed the deadline and my visitor has no pass?

Visitors without parking passes must park on city streets or face a ticket and towing from the Calgary Parking Authority

We live in Red Haus and have one parking stall and a second car. Can we use a visitor pass for our second vehicle?

No. Visitor parking passes are for visitors only – not for residents or for long-term visitors. City street parking is instead available.

Passes have a 7-day maximum. Date tampering will result in fines or one-year pass suspension.
